CITIZENSHIP ELIGIBILITY

- * A lawful permanent resident for at least 4 years and 9 months
- * A lawful permanent resident for a least 2 years and 9 months AND married to a U.S. Citizen for 3 years
- * CAN SPEAK, READ, AND WRITE BASIC ENGLISH

EXCEPTIONS TO TAKING THE TEST IN ENGLISH

* Have a physical, developmental or mental disability

that affects your ability to learn English

- * Have been a lawful permanent resident for at least
- 20 years and are at least 50 years old
- * Have been a lawful permanent resident for at least
- 15 years and are at least 55 years old
- * Have been a lawful permanent resident for at least
- 20 years and are at least 65 years old

REGISTRATION AT TIME OF YOUR APPOINTMENT

DOCUMENTS TO BRING:

* Green card, Social Security card, State ID/ Driver's License,

passports, birth certificate

* List of places you have traveled since becoming a resident,

including dates, you left and returned

- * List of where you have lived and worked the past 5 years
- * If you are married, bring your spouse's: date of birth, Legal Permanent Resident number, date of

naturalization (if applicable), date of marriage

* Information about previous marriages: date of marriage,

date marriage ended, and reason it ended

- * A list of your children including: date of birth, Legal Permanent Resident numbers (if applicable) and complete address
- * If you were ever arrested and detained, information on the reason, date, place and results of the arrest
- * (FOR MEN) Selective service number and date

ELEGIBILITY FOR FEE WAIVER

- * 2017 Federal Income Tax Return
- * Check stubs from last 30 days
- * Unemployed checks and letter (if applicable)
- * LINK, MEDICAL TANF card with a letter from the
- agency starting that you receive those benefits
- * Special circumstances where you are unable to pay
- * Your family earns 150% of the poverty level or less according to the table
